Producer's description

The System Sensor, Model 885WP-B, Type B heat detector is conventional fixed temperature unit. The unit is defined by the manufacturer as "weatherproof', with an IP67 rating, and intended for use in open areas. The heat sensing element has a nominal sensitivity setpoint of 63° C. It is rated for operation over the temperature range from 0° C to +38° C.

Electrical connection to the detector is achieved through six wires (flying leads) in the back of the device. The six wires form 3 pairs of connections facilitating monitoring of the leads by appropriate Control and Indicating Equipment.

The System Sensor, Model 885WP-B, Type B heat detector includes a mounting base providing four slots for screw mounting. The base includes an anti-tamper facility activated by the removal of a small tab. Once activated, the detector cannot be removed from the base without the use of the "tamper key".

The installed unit is approximately 103 mm in diameter with a height of approximately 38 mm (not including flying leads). When connected to the mounting base, it has a total height of 47 mm.
